



Revenue Generation

- The revenue is Generated from Clients. For every recruitment as per the standard market rate we also charge 8.33% of CTC of the candidates to our clients.
- The franchisee who does the complete recruitment process will get a profit sharing of 60% of that billing amount.
- 40% will go to the head office as Royalty to take care of Marketing, Branding & admin expense.
- TDS which is Deducted from the Client is Deducted from Our Share of 40%. Franchisee Gets their Full 60%.
- As Per Government Rules, 2% TDS will Be Deducted for Franchise Share. A TDS Certificate for the same is Provided.
